Thank you for your interest in becoming a Licensee Member of the Friction Materials Standards Institute. The following document outlines the many benefits of becoming an FMSI member.

The FMSI web site (<u>www.fmsi.org</u>) has a list of FMSI members, the objectives of FMSI, the membership eligibility requirements, and other important information. It is also the portal into our members' only electronic catalog.

MEMBERSHIP FEES

The annual membership fee is \$3,350 USD. There is also a onetime initiation fee of \$8,000 USD Given the benefits of membership - particularly the access to information equal to active and regional members, these fees are very modest. Included in the dues fee is access to the FMSI electronic catalog for up to three users. For those members desiring more than three users, there is an additional charge of \$75 per year per user.

APPLICATION FOR MEMBERSHIP

To apply, one copy of the Application Form must be completed and signed by a principal. This form should be sent to FMSI along with a prepayment of the initiation fee plus the first year's annual dues.

As soon as the FMSI Board of Directors has approved the application, a copy of the FMSI Constitution and By-Laws will be sent to you along with a letter in which you agree to adhere to that document. An officer of the company should sign the letter and return it to FMSI. Membership cannot be finalized until this document has been signed and returned. If for some reason you are unable to agree to adherence, the application will be voided, and the payment returned.

- Not a manufacturer of the six products covered by FMSI
- Participates in the industry in one of the following five areas
 - o Manufacture of component parts for brakes
 - o Manufacture of materials for attachment or assembly of brakes
 - o Manufacture of tools and/or equipment used in industry
 - o Test or certify friction materials
 - Rebuild or assemble brakes and clutches
- Licensee members have access to FMSI information
- Licensee members do NOT have the right to use FMSI partnumbers except for product purchased from a manufacturing member
